

# Second Form Laptop Scheme (2023-24)

Students that join the Second Form in September 2023 will be issued with a school managed laptop. This will be charged in twelve instalments at a cost of £115 per term. At the end of the Fifth Form, the laptop will be owned by you. The scheme offers students with a high specification laptop suitable for classroom and home learning.

#### The laptop comes with:

- · A digital pen;
- · Additional e-learning capabilities;
- · Accidental damage cover; and
- A four year warranty\*

**Please note:** Damage due to inappropriate use is **not** covered by the above. Where this is found to be the case, an administration fee and repair costs will be added to the bill. Loss of laptops is **not** covered. Where a laptop is lost, a new device will need to be purchased. Parents are advised to take out additional cover for loss.

Laptops issued from September 2023 come equipped with a protective backpack provided by School Blazer, our uniform supplier. A reduced price of £35 will be added to the September 2023 bill to cover this. Students are required to use the bag at all times when the laptop is not in use.

Children joining the school at the start of the Third, Fourth or Fifth form will be charged an equivalent termly fee for their year group.

If you wish to purchase the laptop at the end of the Firth form, an additional payment will be necessary.

Please note: the spare laptops provided by the school are not covered by the laptop scheme. Any loss or damage to the spare laptops will be chargeable.

Terms and Conditions: \*ADP (Accidental Damage Protection) provides unlimited number of repairs and a single replacement of your Lenovo device for drops, bumps, spills, electric surges and LCD damage. If the system can be repaired, Lenovo guarantees the system will be repaired by a qualified technician using Lenovo qualified parts. If repair is not possible, or the cost of repair is more than the cost of the device, the entire system will be replaced with an equivalent unit at no charge. Only one full device replacement (if required) will be provided within the 4 years. The replacement device would not come with any accidental damage protection but parents may wish to add the device to their own home contents insurance policy. If required and available, a spare laptop will be provided when your device is in for repair. These devices are not covered by accidental damage cover and therefore, if damage or loss occurs when in your child's possession, all repair or replacement costs will be re-charged. Damage classed as malicious, as defined by service engineers, will not be covered by any warranty and the cost of any repair and/or replacement will be the full responsibility of the parent. Students are fully responsible for the security and careful use of the device. The device remains the property of Bloxham School until all payments are complete. If the student leaves the school before completion of all payments the device can either be returned, with no refunds applicable, or else the remaining payments can be made as a one off payment to own the device outright. If a student starts in the Second to Fifth Form at a point in the term other than September, they will be provided with a spare laptop, on a temporary basis, until an appropriate laptop is available. Choice can be made to purchase a new laptop through the school, which will be of an equivalent specification to that used within the year group, with a payment plan to be agreed.
